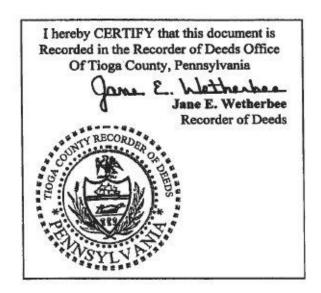

WITNESSETH. That in consideration of ELEVEN THOUSAND DOLLARS AND 00/100THS (\$11,000.00) in hand paid, the receipt whereof is hereby acknowledged, the said Grantor does hereby grant and convey to the said Grantees, as Tenants by the Entireties, their heirs and assigns,

ALL that certain piece or parcel of land situate in Tioga Township, Tioga County, Pennsylvania, described as follows according to a survey conducted by Duane E. Wetmore, P.L.S., dated October, 2005 and Revised February 17, 2006, Map Number 146-05F1 and recorded in Tioga County Register and Recorder's Office as Map File Number ______:

BEGINNING at a point in the centerline of T-697, said point being the southeast corner of lands now or formerly of Mildred E. Cummings and the Southwest corner of the lot herein described;

Cummings, North 18° 25' 07" East a distance of 992.48 feet to an angle point; thence continuing along the eastern boundary line of lands now or formerly of Mildred E. Cummings, the Southwest corner of other lands of the Grantee herein, and the Northwest corner of the lot herein described;

THENCE along the Southern boundary line of other lands of the Grantee herein, North 81° 21' 08" East a distance of 944.76 feet to a point, said point being along the western boundary line of lands now or formerly of Theodore Hughes, the Southeast corner of other lands of the Grantee herein, and the Northeast corner of the lot herein described;

THENCE along lands now or formerly of Theodore Hughes, South 10° 19' 30" West a distance of 790.65 feet to a point along the northern boundary line of lands now or formerly of Linda Jean Stager; thence along lands now or formerly of Linda Jean Stager, the following three (3) courses and distances:

North 72° 24' 37" West a distance of 338.84 feet to a found iron pipe;

South 13° 18' 44" West a distance of 125.00 feet to a point;

SUBJECT TO and TOGETHER WITH the right to use in common with others the existing 50' right of way extending from the centerline of T-697 and shown on the above referenced survey.

EXCEPTING AND RESERVING unto the Grantor the right to use in common with Grantee and others the existing 50' right of way extending from the centerline of T-697 and shown on the above described survey.

As of the date of this deed/plot plan recording, the property/subdivision described herein is and shall be dedicated for the express purpose of lot addition use. No portion of this property/subdivision has been approved by Tioga Township(Municipality) or the Department of Environmental Protection for the installation of sewage disposal facilities. No sewage permit will be issued for the installation, construction, connection to or use of any sewage collection, conveyance, treatment or disposal system (except for repairs to existing systems) unless the municipality and the DEP have both approved sewage facilities planning for the property/subdivision described herein in accordance with the Pennsylvania Sewage Facilities Act (35 P.S. Sections 750.1 et seq.) and regulations promulgated thereunder.
